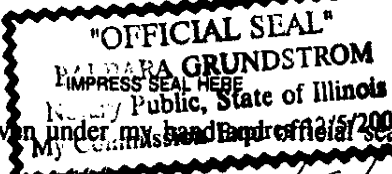

## Legal Description
