

To date, despite due demand for payment, Claimant remains unpaid for said work; and there is no reasonable basis for the failure to pay PAPPAS.

Therefore, after all due credits, the amount left due, unpaid and owing to PAPPAS is \$35,000.00, for which amount, plus interest and collection costs, including reasonable attorneys' fees, PAPPAS claims a lien on the LAND and improvements thereon.





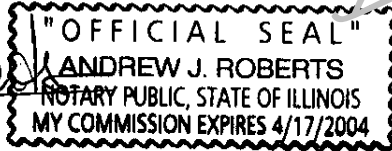
