### NAB PANK ASSIGNMENT OF LEASES AND RENTS

THIS ASSIGNMENT OF LEASES AND RENTS (this "Assignment") dated as of October \(\o\frac{1}{\operation}\), 2000 from VINH HUYNH ("Borrower") to NAB BANK (the "Bank") has reference to the following:

WHEREAS, Borrower has executed and delivered to Bank a Secured Note dated of even date herewith in the original principal amount of \$500,000.00 (the "Mo tgage Note");

WHEREAS, Borrower has also delivered its mortgage (the "Mortgage") to secure the repayment of, among other things, the Mortgage Note, which Mortgage conveys the premises to Bank described in EXHIBIT A hereto (the "Mortgaged Property"); and,

WHEREAS, Borrower desires to further secure (collectively the "Liabilities"): (a) the repayment of the Mortgage Note, and any amendments, renewals, substitutions or replacements thereto; and (b) the performance of Borrower's obligations under the Mortgage and the Mortgage Note.

NOW, THEREFORE, for and in consideration of the above and the mutual agreements herein contained and as further and additional security to Bank for the repayment and performance of the Liabilities, and in consideration of the sum of ONE DOLLAR (\$1.00) to Bank in hand paid, the receipt whereof is hereby acknowledged, Bank and Borrower agree as follows:

- 1. <u>Assignment</u>. Borrower, does hereby sell, assign and transfer unto Bank:
- (a) all Current Leases (as hereinafter defined), future leases, contracts or any other agreements relative to the ownership, sale or occupancy of all or any portion of the Mortgaged Property (or any part thereof), whether written or verbal, whether heretofore now or hereafter made or agreed to or which may be made or agreed to by Bank under the powers granted in this Assignment (the "Leases");
- (b) all rents, issues, profits, revenues, royalties, bonuses, rights and benefits due, payable or accruing (including all deposits or money as advance rent, for security or as earnest money or as down payment for the purchase of all or any part of the Mortgaged Property) now due and which may hereaster cecome due under or by virtue of: (i) the Leases; and/or (ii) any letting of, or any agreement for the use and occupancy of, the Mortgaged Property of any part thereof; and
  - (c) all guaranties of any of the foregoing.
- 2. <u>Representations Re: Leases.</u> Borrower agrees, represents and warrants unto Bank, its successors and assigns as ichrows:
- (a) Borrower is the sole owner of any Leases existing as of the present date with respect to the Mortgaged Property or part there of if any (the "Current Leases");
- (b) no default exists on the part of lessor or lessee under the terms of any Current Leases and there exists no state of facts which, with the giving of notice or lapse of time or both, would constitute a default under any of the Current Leases;
- (c) any Current Leases are, and any future Leases will be, valid and enforceable in accordance with their terms and shall remain in full force and effect irrespective of any merger of the interest of lessor and lessee thereunder;
- (d) if any Current Leases or future Leases provide for the abatement of rent during repair of the demised Mortgaged Property by reason of fire or other casualty, Borrowe, shall furnish rental insurance to Bank in amount and form and written by insurance companies as shall or satisfactory to Bank;
- (e) Borrower shall perform all of the covenants and agreements as lessor under any Current Leases and any future Leases and shall not suffer or permit to occur, any release of liability of the lessee therein, or any right of the lessee therein to withhold payment of rent;
- (f) Borrower shall not amend or modify the material terms (which shall include, without limitation the lease term and rental amount) of any Current Leases or future Leases without the prior written consent of Bank;

- (g) if so requested by Bank after default under any Current Leases or any future Leases, the Borrower shall enforce any one or several of the Current Leases and all remedies available to Borrower against the lessee therein named;
- (h) all future Leases shall be executed in the name of Borrower and, when executed, a copy shall be immediately delivered to Bank.
- 3. Representations Re: Rent. Borrower represents and agrees that no rent has been or will be paid by any person in possession of any portion of the Mortgaged Property for more than one installment in advance. Except for concessions given in the ordinary course of Borrower's business and in connection with the execution of any Leases, no payment of rents to accrue for any portion of said Mortgaged Property will be waived, released, reduced, or discounted, or otherwise discharged or compromised or Borrower. Borrower waives any right of set-off against any person in possession of any portion of the Mortgaged Property. Borrower agrees not to make any other or further assignment of the rents or profits or Leases prior to the release of this Assignment.
- 4. <u>Further Assurances</u>. Borrower further agrees to execute and deliver immediately upon the request of Bank, all such further assurances and assignments in the Mortgaged Property as Bank shall from time to time reasonably require.
- 5. Absolute Transfer/Events of Default. It is parties intention to establish an absolute transfer and assignment of the Leases and agreements, and all the avails thereof, to Bank. Borrower hereby irrevocably appoints Bank as its true and lawful attorney in its name and stead to effectuate the purposes of this Assignment. Although it is the intention of the parties that this Assignment is a present assignment, it is expressly understood and agreed, anything herein contained to the contrary notwithstanding, that Bank shall not exercise any of the rights and powers conferred upon it herein until and unless one or more of the following events shall occur which shall constitute "Events of Default" hereunder:
- (a) an Event of Default shall occur under the terms of the Mortgage Note or in the payment or performance of the Liabilities;
- (b) Default shall occur in performance or observance of any of the agreements or conditions in the Mortgage;
- (c) default shall be made in the performance or observance of any of the conditions or agreements hereunder and Borrower shall fail to cure such within ten (10) days after being served with written notice from Bank; and/or
- (d) default or an Event of Default under any other agreement, security agreement, assignment, instrument or other agreement made by Borrower in favor of Bank;

and in each instance, all applicable cure or grace periods, if any, shall have expired, and nothing herein contained shall be deemed to affect or impair any rights which Bank may have under said Liabilities or any other instrument herein mentioned.

- 6. <u>Remedies: Leases</u>. Upon the occurrence of an Event of Default, Borrower hereby authorizes Bank to:
- (a) direct and instruct each and every present and future lessee or tenant of the whole or any part of the Mortgaged Property to pay all unpaid rental or other amounts agreed upon in any Leases to Bank directly;
- (b) collect all of said avails, rents, issues and profits arising from or accruing at any time hereafter, and a'l now due, or that may hereafter become due under each and all of the Leases and agreements, written or verbal, or other tenancy existing or which may hereafter exist on the Mortgaged Property, and
- (c) rent, lease or let all or any portion of the Mortgaged Property to any party or parties at such rental and upon such terms, as Bank in its discretion may determine; and

all with the same rights and power and subject to the same immunities, exoneration of liability and rights of recourse and indemnity as Bank would have upon taking possession of the Mortgaged Property pursuant to the provisions hereinafter set forth.

- 7. <u>Remedies: Possession</u>. In any case in which under the provisions of the Mortgage Bank has a right to institute foreclosure proceedings, for thwith, upon demand of Bank, Borrower agrees to surrender to Bank and Bank shall be entitled to take actual possession of the Mortgaged Property or any part thereof personally, or by its agents or accorneys, and Bank in its discretion may:
- (a) with or without force and with process of law, enter upon and take and maintain possession of all or any part of the Mortgaged Property, together with all the documents, books, records, papers and accounts of Borrower or then owner of the Mortgaged P operty relating thereto;
  - (b) exclude the Borrower, its agents or servants, wholly therefrom;
- (c) as attorney in fact or agent of the Borrower, or in its own name as Bank and under the powers herein granted, hold, operate, manage and control the Mortgaged Property and conduct the business, if any, thereof either personally or by its agents, with full power to use such measures, legal or equitable, as in its discretion or in the discretion of its successors or assigns may be deemed proper or necessary to enforce the payment of security of the avails, rents, issues and profits of the Mortgaged Property, including:

- (i) actions for the recovery of rent, actions in forcible detainer and actions in distress of rent, hereby granting full power and authority to exercise each and every of the rights, privileges and powers herein granted at any and all times hereafter;
- (ii) cancellation or termination of any Lease or sublease for any cause or on any ground which would entitle Borrower to cancel the same;
- (iii) disaffirm any Lease or sublease made subsequent to the Mortgage or subordinated to the lien thereof;
- making all necessary or proper repairs, decorating, renewals, replacements, alterations, additions, betterments and improvements to the Mortgaged Property that may seem judicious, in its discretion; and/or
- (v) inturing and reinsuring the same for all risks incidental to Bank's possession, operation and management and to receive all such avails, rents, issues and profits.
- 8. <u>Application of Rents</u>. Fark in the exercise of the rights and powers conferred upon it by this Assignment shall have full power to use and apply the avails, rents, issues and profits of the Mortgaged Property to the payment of or or account of the following, in such order as Bank may determine:
- (a) To the payment of the operating expenses of the Mortgaged Property, including cost of management and leasing thereof (which shall include exsonable compensation to Bank and its agent or agents, if management be delegated to an agent or agents, and it shall also include Lease commissions and other compensation and expenses of seeking and procuring tenants and entering into Leases establishing claims for damages, if any, and premains on insurance hereinabove authorized);
- (b) To the payment of all repairs, decorating, renewals, repiacements, alterations, additions, or betterments, and improvements of the premises, including, without limitation, the cost from time to time of installing or replacing such fixtures, furnishings and equipment therein, and of placing the Mortgaged Property in such condition as will, in the reasonable judgment of Bank, make it readily rentable;
- (c) To the payment of the Liabilities and any other indebtedness secured by the Mortgage or any deficiency which may result from any foreclosure sale.
- 9. <u>No Obligation; Indemnity</u>. Bank shall not be obligated to perform or discharge, nor does it hereby undertake to perform or discharge, any obligation, duty or liability under any Leases or rental agreements relating to the Mortgaged Property. Borrower shall and does hereby agree to indemnify and hold Bank harmless of and from any and all liability, loss or damage which it may or

might incur under any Lease or under or by reason of the assignment thereof and of and from any and all claims and demands whatsoever which may be asserted against it by reason of any alleged obligations or undertakings on its part to perform or discharge any of the terms, covenants or agreements contained in said Leases. Should Bank incur any such liability, loss or damage, under said Leases or under or by reason of the assignment thereof, or in the defense of any claims or demands, Borrower agrees to reimburse Bank for the amount thereof, including direct costs, direct expenses and reasonable attorneys' and paralegals' fees, immediately upon demand.

- Remedies Generally; Governing Law; Notices. It is understood and agreed that the provisions set forth in this Assignment herein shall be deemed a special remedy given to Bank, and shall not be deemed exclusive of any of the remedies granted in the Mortgage, but shall be deemed an additional remedy and shall be cumulative with the remedies therein granted and elsewhere granted in any instrument securing the Liabilities, all of which remedies shall be enforceable concurrently or successively. This Assignment shall be governed by and construed under the laws of the State of Illinois. Any notice required hereunder shall be sent to Borrower via hand delivery, via nationally recognized over-night mail carrier, or via registered or certified U.S. mail, return receipt requested, sent to the address listed below (or any different address specified by Borrower in writing to Bank) and shall be deemed served: (a) on the date delivered if hand delivered or if sent by nationally recognized over-night mail carrier, or (b) two (2) days after mailing the notice if served by registered or certified mail. Notices to be served on Bank shall be served in the same manner at 222 West Cermak Road, Chicago, Illinois 60616.
- 11. Mortgagee In Possession. Nothing herein contained shall be construed as constituting Bank a "mortgagee in possession" in the absence of the taking of actual possession of the Mortgaged Property by Bank pursuant to the provisions hereinalter contained. In the exercise of the powers herein granted to Bank, no liability shall be asserted or enforced against Bank, all such liability being expressly waived and released by Borrower.
- Defined Terms. Whenever the word "Borrower" is mentioned herein, it is hereby understood that the same includes and shall be binding upon their successors and assigns (including successors by consolidation), and any party or parties holding title to the Mortgaged Property by, through or under them. All of the rights, powers, privileges and immunities granted and assigned to Bank shall also inure to its successors and assigns, including all holders, from time to time, of the Mortgage Note or the Liabilities. If this instrument is executed by more than one person or entity, all obligations and undertakings of Borrower herein shall be joint and several. Further, the term "Mortgage Note" as used herein shall also be read to refer to any note or instrument executed in renewal, substitution, amendment or replacement thereto.
- 13. <u>Effect of Assignment</u>. It is expressly understood that no judgment or decree which may be entered on any debt secured or intended to be secured by the Mortgage shall operate to abrogate or lessen the effect of this instrument, but the same shall continue in full force and effect until the payment and discharge of any and all indebtedness secured by the Mortgage, in whatever form the said indebtedness may be until the indebtedness secured by the Mortgage shall have been paid in full and all bills incurred by virtue of the authority herein contained have been fully paid out

of rents, issues and profits of the Mortgaged Property, or by Borrower, or until such time as this instrument may be voluntarily released. This instrument shall also remain in full force and effect during the pendency of any foreclosure proceedings, both before and after sale, until the issuance of a deed pursuant to a foreclosure decree, unless the indebtedness secured by the Mortgage is fully satisfied before the expiration of any period of redemption.

- 14. <u>Enforcement Costs</u>. In the event that Bank incurs any reasonable costs (including attorneys' and paralegals' fees, court costs and advances) to enforce the provisions of this Assignment, the Borrower on demand by Bank, immediately shall reimburse Bank therefor. Borrower's liability for all reasonable expenses and fees hereunder shall also extend to the collection of any judgment which shall result from Bank's enforcement of its rights and remedies under this Assignment.
- BANK'S SOLE DISCRETION, ALL ACTIONS OR PROCEEDINGS IN ANY WAY OR RESPECT, ARISING OUT OF OR FROM OR RELATED TO THIS ASSIGNMENT SHALL BE LITIGATED IN COURTS HAVING SITUS WITHIN THE COUNTY OF COOK IN THE STATE OF ILLINOIS. BORROWER AND BANK HEREBY CONSENT TO THE JURISDICTION OF ANY LOCAL, STATE, OR FEDERAL COURT LOCATED WITHIN SAID COUNTY AND STATE AND WAIVE ANY OBJECTION THEY MAY HAVE BASED ON IMPROPER VENUE OR FORUM NON CONVENIENS TO THE CONDUCT OF ANY PROCEEDING HEREUNDER.
- 16. Jury Waiver. BORROWER AND BANK IRREVOCABLY WAIVE ANY RIGHT TO TRIAL BY JURY IN ANY ACTION OR PROCEEDING: (a) TO ENFORCE OR DEFEND ANY RIGHTS UNDER OR IN CONNECTION WITH THIS ASSIGNMENT OR ANY AMENDMENT, INSTRUMENT, DOCUMENT OR AGREEMENT DELIVERED OR WHICH MAY IN THE FUTURE BE DELIVERED IN CONNECTION HEREWITH; OR (b) ARISING FROM ANY DISPUTE OR CONTROVERSY IN CONNECTION WITH OR RELATED TO THIS ASSIGNMENT OR ANY SUCH AMENDMENT, INSTRUMENT, DOCUMENT OR AGREEMENT, AND AGREE THAT ANY SUCH ACTION OR PROCEEDING SHALL BE TRIED BEFORE A COURT AND NOT BEFORE A JURY.
