ORDER

THIS CAUSE COMING on Motion of the Petitioner, April Bernes, for increase in child support and to establish accountability for educational expenses, due notice having been given and the court having been fully advised in the premises, including review of the pleadings of record, stipulations of counsels, the parties testimony in open court, and the submission of sworn financial statements. THE COURT FINDS:

1. That the party's adult child, Jennifer Bernes, is in need of educational support.
2. That she is currently enrolled as a junior at Northern University.
3. That there was no prior agreement among the parties for her educational expenses.
4. That the Respondent, Mitch Bernes, did previously provided educational expenses for Jennifer Bernes in the amount of \$9,496 while she attended Harper Community College.
5. That the parties have adequate resources to contribute to Jennifer's educational expenses.

6. That there has been a \$500 over payment in child support.
7. That there has been a substantial change in circumstances.

IT IS HEREBY ORDERED

1. That Mitchell Berns and April Berns are to each pay 50% of the cost of tuition, textbooks, room and board, and educational fees for Jennifer, so long as she is enrolled as a full time student in good standing at Northern University working towards her undergraduate degree. In addition, each parent is to send Jennifer Berns, on the first of each month, \$200 for miscellaneous out of pocket educational expenses.
2. That Mitchell Berns and April Berns are to each pay 50% of Jennifer Bern's student loans in the amount of \$5,880. Jennifer Berns is ordered and has agreed in open court to discontinue her part time job for at least one year to focus on her educational studies.
3. That April Berns pay Mitchell Berns \$4,748 being one half of the \$9,496 he previously paid for educational expenses.
4. That Mitchell Berns' child support be increased to \$825 per month, retroactive to March 29, 2000, until the minor child, David Berns, reaches the age of 18 or May 2, 2001 or upon completion of high school, which ever is later. That Mitchell is entitled to a child support credit of \$500 caused by an over payment to the State Disbursement Unit.

5. That Mitch Berns and April Berns is given authority to obtain copies of any school records and documents, including financial records and invoices and that Jennifer Berns shall signed any waivers or authorization to that effect.
6. That Mitchell Berns will obtain and deliver a duplicate insurance card for Jennifer and David Berns within the next 14 days.
7. That the parties are ordered to pay their own attorneys' fees and costs.
8. That the Court retains jurisdiction to enforce the terms of this order.
9. That this matter is reviewable in one year on notice of either party.


