ORDER OF PERMANENT INJUNCTION

This matter coming on to be heard on the regular trial call and on motion of plaintiff, City of Chicago, and the court having jurisdiction over the parties and subject matter and having been fully advised in the premises, the court orders:

1. Defendant(s) Teresia Camacho and Santer Camacho his/her/their agents, heirs, successors or assigns, be and are permanently enjoined and restrained from renting, leasing, using or occupying the attic and the basement of the subject premises as dwelling units. The premises shall remain as a single family dwelling.

2. The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction.

3. This order is final and appealable, the court finding no just cause or reason to delay its enforcement or appeal.

4. The defendants must deconvert the premises by capping the pipes in the basement behind the wall and hire a licensed plumber to do all of the work.
