**NOTICE** is hereby given that, **AUTOMATIC FIRE CONTROLS, INC.**, formerly known as Automatic Suppression Systems, Inc., of 130 Armory Drive, South Holland, County of Cook, State of Illinois (hereinafter referred to as the "claimant"), hereby files notice and claim for mechanics' lien against **MERLINO CONSTRUCTION CO, INC.**, of 5400 Newport Drive, Unit 18, Rolling Meadows, County of Cook, State of Illinois (hereinafter referred to as the "contractor"), and **THE FRENCH INSTITUTE**, of 562 Green Bay Road, Winnetka, County of Cook, State of Illinois, **CHICAGO TITLE AND TRUST COMPANY, as Trustee U/T/D February 3, 2000, a/k/a Trust No. 1108030** (hereinafter referred to as "owner"), of Chicago, County of Cook, State of Illinois, **Bank One, N.A.**, of Chicago, County of Cook, State of Illinois, (hereinafter referred to as the "mortgagee"), and states:

That on July 10, 2000, said contractor made a subcontract with the claimant to provide labor, supplies, and materials for installation of a fire alarm system for and in said improvement, for a contract price of \$9,544.00, and that on September 11, 2000, the claimant completed thereunder the installation of said fire alarm system.

That upon completion of said subcontract, contractor became indebted to the claimant in the amount of \$9,544.00. That said contractor is entitled to credits on account thereof as follows: payment totaling \$7,594.00, leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of **One Thousand Nine Hundred and Fifty (\$1,950.00) Dollars**, for which, with interest the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.

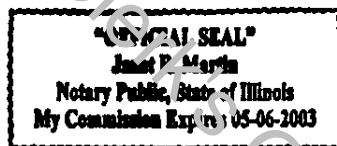

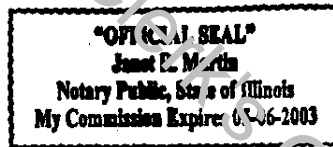
