

#### SUBCONTRACTOR'S NOTICE AND CLAIM FOR LIEN

Claimant Crouc'i-Walker Corporation, 1307 West Wrightwood Avenue, Chicago, Illinois, hereby files a Notice and Claim for Mechanics Lien against Graycor Construction Company, Inc., 1 Graycor Drive, Homewood, Illinois, (hereinafter "Contractor"), Illinois Cinemas, Inc., 700 South Second Screet, Springfield, Illinois (hereinafter "Illinois Cinemas") and Country Club Hills, L.L.C., 225 West Wacker Drive, Suite 3000, Chicago, Illinois (hereinafter "Owner"), and states:

1. That on or about March 28, 2, 100, Owner owned land in the County of Cook, State of Illinois, commonly known as 4201 Wes. 167<sup>th</sup> Street, Country Club Hills, with a permanent index number of 28-27-200-003-0000, and the following legal description:

LOT 2 IN PLAT OF GATLING COUNTRY CLUB HILLS SUBDIVISION RECORDED JANUARY 1.. 2000, AS DOCUMENT 00 027 407, BEING A SUBDIVISION OF PART OF THE NORTHEAST 1/4 OF SECTION 27, TOWNSHIP 36 NORTH, RANGE 13 EAST OF THE THIRD PLINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

Said property, together with all improvements, hereinafter referred to as the "Premises."

- 2. On information and belief, on or prior to March 28, 2000, Illinois Cinemas entered into a contract with the Contractor wherein Contractor was to provide labor, materials and equipment for the construction of a new 16 screen Loews Theatre on and for the benefit of the Premises.
- 3. Illinois Cinemas either owns the Premises in conjunction with Owner or Owner knowingly permitted or authorized Illinois Cinemas to contract for the improvement of the Premises.
- 4. On or about March 28, 2000, Contractor entered into a written subcontract with Claimant to furnish labor and materials in relation to the masonry on the Premises. In return for said services and materials, Contractor agreed to pay Claimant \$167,000.00.

- 5. On October 13, 2000, Claimant completed work under the contract to the sum of \$160,320.00.
- 6. On information and belief, the labor, materials, supplies, equipment and services performed and/or supplied by Claimant in completing said work were done with the knowledge and consent of Owner and Illinois Cinemas.
- 7. Contractor is entitled to no credits, leaving due, unpaid and owing to Claimant the sum of \$160,320.00 for which, with interest, Claimant claims a Mechanics Lien on the Premises Topology of Colling Clark's Office and on the monies or other considerations due or to become due from Owner and/or Illinois Cinemas under its contract with Contractor.
