COVENANT

Re. Sewer Line Maintenance

This Covenant is made by Dimitri Kourkouvis and Dimitrios Giannetos, ("Owners").

Owners are the title holders of the real extrate which is legally described in Exhibit A attached hereto (the "Montrose Property"). 
