You shall promptly notify the insurer and us of any loss. We may make proof of loss if you do not promptly do so.

Insurance proceeds shall be applied to restore or repair the Property damaged, if restoration or repair is economically feasible and our security would not be lessened. Otherwise, insurance proceeds shall be applied to sums secured by this Mortgage, whether or not then due, with any excess paid to you. If you abandon the Property, or do not answer within 30 days our notice to you that the insurer has offered to settle a claim, then we may collect and use the proceeds to repair or restore the Property or to pay sums secured by this Mortgage, whether or not then due. The 30-day period will begin when notice is given. Any application of proceeds to principal shall not require us to extend or postpone the due date of monthly payments. - Hazardous Substances. You shall not cause or permit the presence, use, disposal, storage, or release of any Hazardous Substances on or in the Property. - **B. Hazard Insurance.** So long as the Owners Association maintains, with a generally epted insurance carrier, a "master" or "blanket" policy on the Condominium Project which satisfactory to Lender and which provides insurance coverage in the amounts, for the lods, and against the hazards Lender requires, including fire and hazards included within term "extended coverage," then:

- (iv) any action which would have the effect of rendering the public liability incurance erage maintained by the Owners Association unacceptable to Lender.
- F. Remedies. If Borrower does not pay condominium dues and assessments when due, it is Lender may pay them. Any amounts disbursed by Lender under this paragraph F shall ome additional debt of Borrower secured by the Security Instrument.
