EXEMPT UNDER PARAGRAPH E SECTION 4 OF THE REAL ESTATE TRANSFER TAX ACT

And the said crantors hereby expressly waive and release any and all right or benefit under and by virtue of any and all statutes of the State of Turois, providing for the exemption of homesteads from sale on execution or otherwise.
