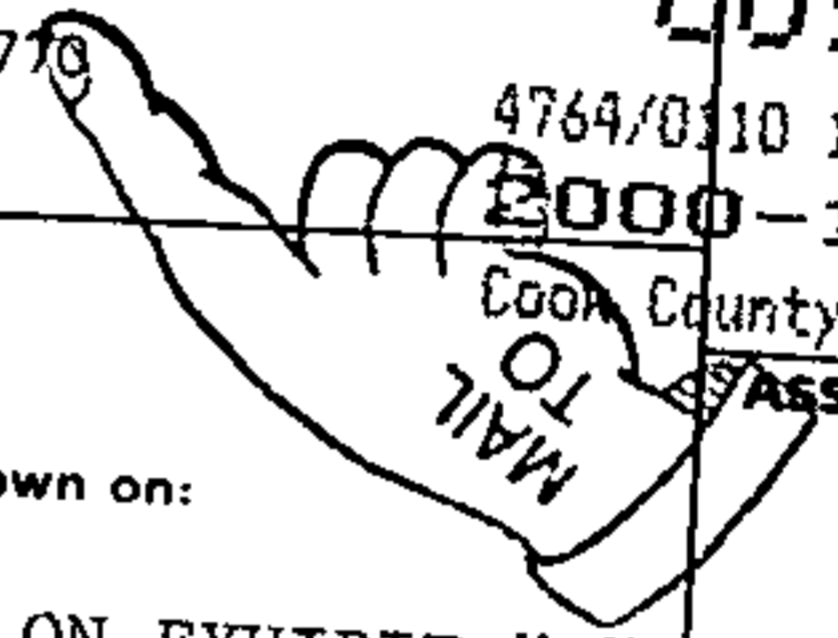

This Financing Statement covers the following property:
