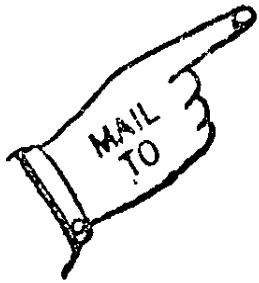

SPECIAL WARRANTY DEED



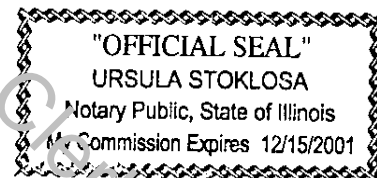
