MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated November 22, 2000, is made and executed between Robert Stevens and Paul Stevens, in joint tenancy, whose address is 9330 S. Harlem Avenue, Bridgeview, IL 60455 (referred to below as "Grantor") and Community Bank of Ravenswood, whose address is 2300 W. Lawrence Avenue, Chicago, IL 60625 (referred to below as "Lender").

MORTGAGE. Lender and Grantor have entered into a Mortgage dated January 10, 2000 (the "Mortgage") which has been recorded in Cook County, State of Illinois, as follows:

Second Mortgage recorded as Document No. 00031043 and Assignment of Rents recorded in conjunction to the mortgage referenced herein as document No. 00031044.

REAL PROPERTY DESCRIPTION. The Mortgage covers the following described real property located in Cook County, State of Illinois:

THE SOUTH 1/2 OF LOT 28 (EXCEPT THAT PART THEROF TAKEN FOR THE WIDENING OF HARLEM AVENUE) IN ROBERT BARTLETT'S 95TH AND HARLEM AVENUE ACRES, BEING A SUBDIVISION OF PART OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 1, TOWNSHIP 37 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLACT THEREOF REGISTERED AS DOCUMENT NO. 701600, IN COOK COUNTY, ILLINOIS

MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

- (1) Increase the existing Revolving Line of Credit from \$325,000.00 to \$475,000.00 granting additional credit to the line of \$150,000.00 as of the effective date; and;
- (2) Add additional collateral to the existing loan indebtedness by assigning to "Lender" a Second Mortgage and Assignment of Rents on the Real properties commonly known as W 7059 Highway 21, Wautoma, Wisconsin; and; N 2213 Highway 73, Wautoma, Wisconsin, in Waushara County .

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
