LOAN MODIFICATION AGREEMENT

THIS AGREEMENT, is made and entered into as of October 25, 2000, but made effective as of December 10, 2000, by and between MID TOWN BANK AND TRUST COMPANY OF CHICAGO, an Illinois corporation ("BANK"), MID TOWN BANK AND TRUST COMPANY OF CHICAGO, NOT PERSONALLY BUT AS TRUSTEE UNDER TRUST AGREEMENT DATED NOVEMBER 24, 1993 A/K/A TRUST NO. 1868 ("BORROWER") & RONALD F. KELLY and MARY T. DONOGHUE, HIS WIFE, ("GUARANTORS").

WHEREAS:

- 1. The BORROWER has heretofore executed a Promissory Note dated **December 10, 1993** in the principal amount of \$380,000.00 of which the BANK is presently the holder;
- 2. The NOTE is secured by a Mortgage, Assignment of Rents & Security Agreement (Chattel Mortgage) dated **December 10, 1993** and recorded in the Recorder's Office of Cook County, Illinois, as document number **94036668** ("MORTGAGE"), conveying to BANK cercin real estate described in Exhibit "A" attached hereto and by this reference incorporated herein ("REAL ESPATE");
- 3. The NOTE is further secured by a Collateral Assignment of the Beneficial Interest in that certain Land Trust which is known as Mid Town Bank and Trust Company of Chicago a/t/1. Trust Agreement dated November 24, 1993 a/k/a Trust No. 1868 ("ASSIGNMENT OF BENEFICIAL 1N TEREST") which land trust holds title to the described REAL ESTATE;
- 4. The NOTE is further secured by Personal Guaranty(s) ("GUARANTY(S)") dated of even date therewith and executed by the GUARANTORS guaranteeing repayment of the indebtedness evidenced by said NOTE;
- 5. The BANK has disbursed to BORROWER the sum of \$380,000.00 which amount represents the entire principal sum of the indebtedness evidenced by the NOTE;
- 6. The interest rate evidenced on said NOTE is **8.125% per annum**;
- 7. The maturity date evidenced on said NOTE is **December 10, 2000**;
- 8. The BORROWER desires to amend the **loan amount, interest rate, repayment term and maturity date** as evidenced by the NOTE;

9. The BANK has agreed to such modification pursuant to the terms and conditions of a commitment of the BANK dated **November 3, 2000** ("COMMITMENT").

NOW THEREFORE, notwithstanding anything contained to the contrary in the NOTE, MORTGAGE, AND GUARANTY(S), and in consideration of the mutual covenants, conditions, and premises contained herein, the PARTIES HERETO AGREE AS FOLLOWS:

- A. The principal amount evidenced by the NOTE as of the effective date is \$328,732.55.
- B. The interest rate evidenced by the NOTE as of the effective date is 8.25% per annum.
- C. Principal and interest payments in the amount of \$2,926.21 (based on a declining 18 year amortization) shall be due and payable monthly beginning January 10, 2001, and on that day each month thereafter until all of said outs anding principal plus any remaining accrued interest and late charges, if any, are repaid in full.
- D. The maturity date is hereby amended to **December 10, 2005**.
- E. Except as modified herein, the terms, covenants and conditions of the MORTGAGE AND GUARANTY(S) shall remain unchanged and otherwise in full force and effect. In the event of any inconsistency between the terms of this agreement and the terms of the NOTE and/or MORTGAGE AND GUARANTY(S), the terms herein shall control.
- F. The lien of the MORTGAGE is hereby modified as security for the payment of the principal sum evidenced by the NOTE and amended by this MODIFICATION AGREEMENT.
- G. This agreement shall be governed by and construed under the laws of the State of Illinois.

This instrument is executed by Mid Town Bank and Trust Company of Chicago not personally but solely as trustee, as aforesaid. All the covenants and conditions to be performed hereunder by Mid Town Bank and Trust Company of Chicago are undertaken by it solely as Trustee, as aforesaid and not individually, and no personal liability shall be asserted or be enforceable against Mid Town Bank and Trust Company of Chicago by reason of any of the covenants, statements, representations or warranties contained in this instrument.
