5. Hazard Insurance. Borrover shall keep the improvements now existing or pereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and such other hazards as Lender may require and in such amounts for such periods as Lender may require.

- 11. Successors and Assigns Bound, Joint and Several Liability; Co-Signers.
