City seeks, among other relief, a declaration that defendants' activities are illegal and an injunction requiring defendants to immediately cease the here-named offenses.

The Parties and the Property at Issue

- 3. The City is a municipal corporation and a home rule unit organized and existing pursuant to the laws of the State of Illinois.
- 4. Within the county of Cook and the corporate limits of the City there is a parcel of real estate legally described as:

LOT 323 IN FIRST ADDITION TO CREST LINE HIGHLANDS SUBDIVISION BEING A SUBDIVISION OF PART OF THE NORTHEAST 1/4 OF SECTION 34, TOWNSHIP 38 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

The parcel is commonly known as 40.5 West 82nd Place, Chicago ("the subject property") and has a permanent index number of 19-34-214-017.

- 5. At all relevant times, the subject property was located within an R2 General Residence District.
- 6. At all relevant times to the City's Complaint ("Complaint"), defendants owned, maintained, operated, collected rents from tenants of, or had an increast in the subject property.

 More specifically, FRANCISCO SEVILLA and HECTOR SAENZ are the record owners of the subject property.
- 7. At all relevant times to the Complaint, defendants have maintained on/at the subject property an illegal basement dwelling unit.
