



THIS MORTGAGE ("Security Instrument") is given on NOVEMBER 22, 1996

The mortgagor is JANET OGOREK, ~~SINGLY/FEMALE/NEVER/MARRIED~~ *J.O.*  
("Borrower"). This security is given to FIRST CHOICE MORTGAGE, L.L.C.,  
DIVORCED & NOT SINCE REMARRIED

which is organized and existing under the laws of The State Of Illinois, and whose address is 361 Frontage Road,  
Burr Ridge, IL 60521 ("Lender")

Borrower owes Lender the principal sum of ONE HUNDRED TWO THOUSAND DOLLARS

(U.S. \$102,000.00). This debt is evidenced by Borrower's note dated the same date as this Security  
Instrument ("Note"), which provides for monthly payments, with the full debt, if not paid earlier, due and payable on
