Signeture of Registered Agent of Record)

- 1. The registered office may, but need not be the same as the principal office of the corporation. However, the registered office and the office-address-of-the-registered agent must-be-the same.
- 2. The registered office must include a street-or-road address; a post office box number alone is not acceptable.
- 3. A corporation cannot act as its own registered agent.
