- 9. AUTHORITY TO PERFORM. If Mortgagor fails to perform any duty or any of the covenants contained in this Security Instrument, Lender may, without notice, perform or cause them to be performed. - 11. LEASEHOLDS; CONDOMINIUMS; PLANNED UNIT DEVELOYMENTS. Mortgagor agrees to comply with the provisions of any lease if this Security Instrument is on a leasehold. - 12. DEFAULT. Mortgagor will be in default if any party obligated on the Secured Debt fails to make payment when due. - 13. REMEDIES ON DEFAULT. OPEN-END HOME EQUITY MORTGAGE AMENDMENT

THIS DOCUMENT AMENDS THE PROVISIONS OF THE MORTGAGE FORM WHICH SECURES THE BORROWER'S OPEN-END HOME EQUITY LOAN.

The Section of the mortgage form titled **DEFAULT** is amended, in its entirety, to read as follows:

DEFAULT: This mortgage will be in default if any of the following occurs:

Fraud. Any Consumer Borrower engages in fraud or material misrepresentation in connection with the Secured Debt that is an open-end home equity plan. Fraud (or material misrepresentation), in and of itself, is not a sufficient element of default when the property securing the loan is located in Iowa, Kansas, South Carolina, Wisconsin, but such fraud (or material misrepresentation) may adversely affect the Lender's rights in the property as provided belov.

Paymer's. Any Consumer Borrower on any Secured Debt that is an open-end home equity plan fails to ma' a payment when due. If the property securing the loan is located in Iowa, this means such Borrower. It is to make a payment within 10 days of when it is due. In Wisconsin, this means such Borrower fails to make a payment when due on two or more occasions within any 12-month period.

Property. Any action or maction by the Borrower or Mortgagor occurs that adversely affects the Property or Lender's rights in the Property. This includes, but is not limited to, the following: (a) Mortgagor fails to maintain required insurance on the Property; (b) Mortgagor transfers the Property; (c) Mortgagor commits waste or otherwise destructively uses or fails to maintain the Property such that the action or maction adversely affects the Lender's security; (d) Mortgagor fails to pay taxes on the Property or otherwise fails to act and thereby causes a lien to be filed against the Property that is senior to the lien of this Security Instrument; (e) a sole Mortgagor dies; (f) if more than one Mortgagor, any Mortgagor dies and Lender's security is adversely affected; (g) the Property is taken through eniment domain; (h) a judgment is filed against Mortgagor and subjects Mortgagor and the Property to action that adversely affects Lender's interest; or (I) a prior lienholder forecloses on the Property and as a result, Lender's interest is adversely affected.

Executive Officers. Any Borrower is an executive officer of Lender or an affiliate and such Borrower becomes indebted to Lender or another lender in an a gragate amount greater than the amount permitted under federal laws and regulations.

The Section titled **DUE ON SALE OR ENCUMBRANCE** is amended to read as follows (in Wisconsin, the first paragraph of such section is amended to read as follows):

DUE ON SALE. Lender may, at its option, declare the entire balance of the Secure! Debt to be immediately due and payable upon the creation of, or contract for the creation of a transfer or sale of the Property. This right is subject to the restrictions imposed by federal law (12 C.F.R. 591), as applicable.
