### LOAN MODIFICATION AGREEMENT

THIS AGREEMENT, is made and entered into as of December 28, 1999, but made effective as of December 1, 1999, by and between MID TOWN BANK AND TRUST COMPANY OF CHICAGO, an Illinois corporation ("BANK"), MID TOWN BANK AND TRUST COMPANY OF CHICAGO, NOT PERSONALLY BUT AS TRUSTEE UNDER TRUST AGREEMENT DATED October 25, 1994 A/K/A TRUST NO. 1935 ("BORROWER") & WILLIAM MOORF AE AD, ("GUARANTOR").

#### WHEREAS:

- 1. The BORROWER has heretofore executed a P omissory Note dated **November 10, 1994** in the principal amount of \$181,350.00 of which the BANK is presently the holder;
- 2. The NOTE is secured by a Mortgage, Assignment of Keni's & Security Agreement (Chattel Mortgage) dated November 10, 1994 and recorded in the Recorder's Office of Cook County, Illinois, as document number 94970480 ("MORTGAGE"), conveying to BANK certain real estate described in Exhibit "A" attached hereto and by this reference incorporated herein ("REAL ESTATE");
- 3. The NOTE is further secured by a Collateral Assignment of the Beneficial Interest in that certain Land Trust which is known as Mid Town Bank and Trust Company of Chicago a/vu Trust Agreement dated October 25, 1994 a/k/a Trust No. 1935 ("ASSIGNMENT OF BENEFICIAL TYTEREST") which land trust holds title to the described REAL ESTATE;
- 4. The NOTE is further secured by Personal Guaranty ("GUARANTY") dated of even date therewith and executed by the GUARANTOR guaranteeing repayment of the indebtedness evidenced by said NOTE;
- 5. The BANK has disbursed to BORROWER the sum of \$181,350.00 which amount represents the entire principal sum of the indebtedness evidenced by the NOTE;
- 6. The interest rate evidenced on said NOTE is 8.75% per annum;
- 7. The maturity date evidenced on said NOTE is **December 1, 1999**;
- 8. The BORROWER desires to amend the **loan amount, interest rate, repayment term and maturity date** as evidenced by the NOTE;

. 9. The BANK has agreed mo lift ation ows tank to the terms and conditions of a commitment of the BANK dated December 28, 1999 ("COMMITMENT").

NOW THEREFORE, notwithstanding anything contained to the contrary in the NOTE, MORTGAGE, AND GUARANTY, and in consideration of the mutual covenants, conditions, and premises contained herein, the PARTIES HERETO AGREE AS FOLLOWS:

- The principal amount evidenced by the NOTE as of this date is \$172,571.15000230 A.
- The interest rate evidenced by the NOTE as of the effective date is 8.50%. B.
- C. Principal and interest payments in the amount of \$1,389.59 (based on a 25 year amortization) shall be due and payable monthly beginning January 1, 2000, and on that day each month thereafter until all of said outstanding principal plus any remaining accrued interest and late charges, if any, are repaid in full.
- D. The maturity date is rereby amended to **December 1, 2004**.
- E. Except as modified hereir, the terms, covenants and conditions of the MORTGAGE AND GUARANTY shall remain unchanged and otherwise in full force and effect. In the event of any inconsistency between the terms of this agreement and the terms of the NOTE and/or MORTGAGE AND GUARANTY, the terms herein shall control.
- F. The lien of the MORTGAGE is herety modified as security for the payment of the principal sum evidenced by the NOTE and amended by this MODIFICATION AGREEMENT.
- This agreement shall be governed by and construed under the laws of the State of Illinois. G.

This instrument is executed by Mid Town Bank and Trust Company of Chicago not personally but solely as trustee, as aforesaid. All the covenants and conditions to be performed bereunder by Mid Town Bank and Trust Company of Chicago are undertaken by it solely as Trustee, as afore aid and not individually, and no personal liability shall be asserted or be enforceable against Mid Town Bank and Tust Company of Chicago by reason of any of the covenants, statements, representations or warranties contained in this justrument.
