### ASSIGNMENT AND ASSUMPTION AGREEMENT

THIS ASSIGNMENT AND ASSUMPTION AGREEMENT (this "Agreement") dated as of December 1, 1999 is by and between 5800 DEVELOPMENT CORP., INC., an Illinois corporation ("Assignor") and Herman G. Weinberger, as Trustee of the Herman G. Weinberger 1991 Trust ("Assignee").

### **RECITALS**

C., an Illinois limited liability company ("CLH") executed an Installment Note ("Note") dated December 1, 1999 in the original principal amount of Seven Hundred Fifty Thousand and No/100 Dollars (\$750,000.00) in favor of Assignor secured by that certain Mortgage ("Mortgage") dated December 1, 1999, recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on December 1, 1999 as document # **00045559**, against the Premises more particularly described on Exhibit A, attache the reto.
- B. Assignor desires to assign all of its rights, obligations, liabilities and interests in, to and under the Note and Mortgage to Assignee and Assignee desires to accept the assignment of the Note and the Mortgage.

NOW, THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. Assignment. Assignor hereby assigns, transfers, conveys, sets over and delivers to Assignee and Assignee hereby accepts the assignment and transfer all of Assignor's rights, obligations, liabilities, and interests in, to and under the Note and the Mortgage to Assignee.
- 2. Severability. The invalidity of any provision of this Agreement shall not affect the validity of any other provision of this Agreement.

- 3. Applicable Law. This Agreement shall be governed and controlled as to validity, enforcement, interpretation, construction, effect and in all other respects by the internal laws of the State of Illinois, without regard to principles of conflicts of laws.
- 4. Binding Effect; Benefit. This Agreement shall inure to the benefit of and be binding upon the parties hereto, and their successors and permitted assigns. Nothing in this Agreement, express or implied, is intended to confer on any person other than the parties hereto, and their respective successors and permitted assigns any rights, remedies, obligations or liabilities under or by reason of this Agreement.
- 5. Counterparts. This Agreement may be executed in multiple counterparts and by facsimile signature, each of which shall be deemed to be an original, and all such counterparts shall constitute but one instrument.
- 6. Entire Agreement. This Agreement constitutes the entire agreement between the parties hereto, with respect to the transactions contemplated herein, and supersedes all prior oral or written agreements, commitments or understandings with respect to the matters provided for herein.
