#### **ASSUMPTION AGREEMENT**

THIS ASSUMPTION AGREEMENT ("Agreement"), is entered into this 28 H day of October, 1999, by and among American National Bank and Trust Company of Chicago, as Trustee Under Trust Agreement Dated May 18, 1979 and known as Trust Number 46537 (hereinafter referred to as "Borrower"); Racine Associates, L.L.C., an Illinois limited liability company (hereinafter referred to as "Successor Borrower"); and American National Bank and Trust Company of Chicago, a national banking association (hereinafter referred to as "Lender").

#### RECITALS

Said Trust Deed and Assignment were subsequently recorded with the Cook County Recorder of Deeds on July 16, 1979 in Cook County, Illinois as Document Nos. 25052322 and 25052323, respectively, concerning real estate legally described in Exhibit "A" attached hereto and incorporated herein; and

WHEREAS, the Trust Deed, Assignment and Note are hereinafter sometimes collectively referred to as the "Loan Documents"; and

WHEREAS, Borrower and Successor Borrower have requested that Lender forbear from calling an Event of Default under the Loan Documents in exchange for Successor Borrower's agreement to formally assume all duties and obligations under said Loan Documents.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties state as follows:

- 1. Borrower has transferred title to the property described in Exhibit "A" to Successor Borrower.
- 2. C.F.I. Partnership (as Beneficiary of Borrower) and the Successor Borrower wish the consent of Lender to such conveyance.
- 3. Borrower, for value received, does hereby assign and transfer unto the Successor Borrower all right, title and interest in and to all monies deposited for taxes with said Lender, its successors and assigns in accordance with the terms and provisions of said Trust Deed.
- 4. Lender does hereby consent to the conveyance of said transfer of title by Borrower to Successor Borrower in lieu of declaring a default under said Trust Deed.
- 5. Successor Perrower hereby agrees to be bound by the terms, conditions and provisions of the Loan Documents previously entered into between Borrower and the Lender, whether direct, indirect, contingent or otherwise;
- 6. Successor Borrower hereby assumes, ratifies and confirms all representations and warranties contained in the Loan Documents and in any and all other documents or agreements heretofore executed by Borrower.
- 7. This Agreement shall inure to the benefit of Lender's successors and assigns, and shall be binding upon Successor Borrower's executors, administrators, successors and assigns.
