THE COVENANTS, CONFITTIONS AND PROVISIONS PREVIOUSLY REFERRED TO ARE:

1. Until the indebtedness aforesaid shall be fully paid, Borrower, and in the case of the failure of Borrower, its successors or assigns shall: (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damage i or destroyed: (b) keep said premises in good condition and repair, without waste, and free from mechanic's lien or other liens or claims for lien not expressly subordinated to the lien hereof; (c) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the wicharge of such prior lien to Trustee or to Holders of the Notes; (d) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (e) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (f) make no material alterations in said premises except as required by law or municipal ordinances; (g) pay before any penalty attaches all general taxes, and pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and upon written request, to furnish to Trustee or to Holders of the Notes duplicate receipts therefore; (h) pay in full under protest, in the manner provided by statute, any tax or assessment which Borrower may desire to contest; (i) keep all buildings and improveme its now or hereafter situated on said premises insured against loss or damage by fire, lightening or windstorm (and flood damage) where the lender is required by law to have its loan so insured) under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness soci red hereby, all in companies satisfactory to the Holders of the Notes, under insurance policies payable, in case of loss of a mage, to Trustee for the benefit of the Holders of the Notes, such rights to be evidenced by the standard mortgage clause to be attached to each policy; and to deliver all policies, including additional and renewal policies, to Holders of the Notes, and 11 case of insurance about to expire, to deliver renewal policies not less than ten days prior to the respective dates of expiration.

6. Borrower shall pay each item of indebtedness herein mentioned when due according to the terms hereof. At the option of the Holders of the Notes, or any of them, and without notice to Borrower, all unpaid indebtedness secured by this Trust Deed shall, notwithstanding anything in the Installment Notes or in this Trust Deed to the contrary, become due and payable (a) immediately in the case of default in making payment of any of the principal or (b) when default shall occur and continue for three days in the payment of any interest or in the performance of any other agreement or promises of the Borrower herein contained. When the indebtedness hereby secured shall become due whether by acceleration or otherwise, Holders of the Notes or Trustee, or any of them shall have the right to foreclose the lien hereof. Borrower gives Trustee and/or Holders of the Notes power to sell the premises at a public auction. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of the Borrower at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occurried as a homestead or not and the Trustee hereunder may be appointed as such receiver. Such receiver shall have the power to collect the rents, issues and profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a deficiency, during the full statutory period of redemption, whether there be redemption or not, as well as during any further times when Borrower, except for the intervention of such receiver, would be entitled to collect such rents, issue and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management, and operation of the premises during the whole of said period.
