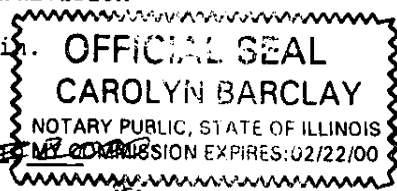
1. The sale or exchange is of an entire tract of land not being a part of a larger tract of land.
