RELEASE, SATISFACTION AND DISCHARGE OF MASTER INDENTURE

WHEREAS, the Series 1983B Obligation, the Series 1985 Obligation, the 1987 Demand Note Obligation, the Series 1987 Obligation, the 1988 Demand Note Obligation, the 1991 Revolving Credit Note Obligation, and the 1993 Demand Note Obligation have been previously refunded, canceled or otherwise satisfied; and

WHEREAS, the Amended Series 1985A Obligation secured the Revenue Refunding Bonds, Series 1985A (MacNeal Memorial Hospital Association Project) (the "Series 1985A Bonds") of the City of Berwyn, Illinois (the "City"); and

WHEREAS, the Series 1991 Obligation secured the Revenue Bonds, Series 1991 (MacNeal Memorial Hospital Association Project) (the "Series 1991 Bonds") of the City; and

WHERFAS, the Series 1995 Obligation secured the Revenue Bonds, Series 1995 (MacNeal Memorial Hospital Association Project) (the "Series 1995 Bonds") of the City; and

WHEREAS, the Amended Series 1985A Bonds have been surrendered to LaSalle Bank National Association, as trustee and have been canceled; and

WHEREAS, the Corporation has placed certain funds in escrow with LaSalle Bank National Association, as trustee for the Serie: 1991 Bonds, which will be sufficient to pay the principal of and interest on all outstanding Series 199. Fonds through their respective dates of maturity; and

WHEREAS, the Corporation has placed certain funds in escrow with LaSalle Bank National Association, as trustee for the Series 1995 Bonds, which will be sufficient to pay the principal of, premium, if any, and interest on the Series 1995 Bonds when due, whether on an interest payment date, by mandatory sinking fund redemption, optional redemption or at maturity, through and including their respective dates of payment.

WHEREAS, the Amended Series 1985A Obligation, the Series 1991 Obligation and the Series 1995 Obligation have each been paid in full by the Corporation and canceled by LaSalle Bank National Association, as bond trustee for such bonds; and

WHEREAS, the Corporation has paid all other sums payable under the Master Indenture; and

WHEREAS, all conditions precedent to the satisfaction and discharge of the Master Indenture have been complied with;

NOW, THEREFORE, in consideration of the premises and of other good and valuable consideration, the receipt and sufficiency whereof is hereby acknowledged, the Master Trustee does hereby forever release, remise, reassign, reconvey, terminate, transfer and set over to and unto the Corporation all of the Master Trustee's rights, title and interest in and to the trust estate and in and to any other property which may have been conveyed, granted, pledged, assigned, confirmed, transferred or set over by the Master Indenture, and all of the Master Trustee's right, title and interest under the Master Indenture does hereby cease, determine and become void. The Master Trustee hereby acknowledges that all obligations of the Corporation in respect of the covenants contained

in the Master Indenture have hereby ceased, determined and been completely discharged. The property which is released hereby includes, but is not limited to, the premises described on Exhibit A attached hereto and made a part hereof, together with all buildings, improvements, leasehold estates, appurtenances and privileges thereunto belonging or appertaining.
