
**LIS PENDENS NOTICE**

That part of the Southwest Quarter of Section 36, Township 37 North, Range 12 East of the Third Principal Meridian, described as follows:

Commencing at the Center of said Section 36; thence on an assumed bearing of South 88 degrees 04 minutes 39 seconds West 125.000 meters [410.11 feet] along the north line of the Southwest Quarter of said section 36; thence South 01 degree 55 minutes 21 seconds East, perpendicular to the last described course, 11.286 meters [37.03 feet], to the point of beginning, said point being on the southerly right of way of 131<sup>st</sup> street as occupied and being 9.034 meters [29.64 feet] southerly from the centerline of 131<sup>st</sup> street as surveyed; thence continuing along last described course of South 01 degree 55 minutes 21 seconds East 0.966 meters [3.169 feet]; thence of South 88 degrees 04 minutes 39 seconds West 115.000 meters [377.30 feet] parallel with the north line of the Southwest Quarter of said section 36; thence South 01 degree 55 minutes 21 seconds East 1.000 meter [3.28 feet]; thence South 88 degrees 04 minutes 39 seconds West 94.000 meters [308.40 feet] parallel with the north line of the Southwest Quarter of said section 36; thence North 01 degree 55 minutes 21 seconds West, perpendicular to the last described course, 1.966 meters [6.45 feet] to the south right of way of 131<sup>st</sup> street, as occupied; thence North 88 degrees 04 minutes 39 seconds East 209.000 meters [685.70 feet] along said right of way to the point of beginning, all in Cook County, Illinois.

Said parcel contains 0.0296 hectare (0.073 acres).
