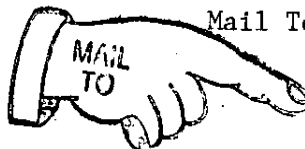

ADDENDUM TO THAT CERTAIN RELEASE (SATISFACTION) OF JUDGMENT EXTENDED BY THE CITY OF CHICAGO, AS JUDGMENT CREDITOR, ON JANUARY 24, 2000 TO JOHN SLIMAK, ET AL., AS TO A JUDGMENT IN THE AMOUNT OF \$4,560 ENTERED ON NOVEMBER 13, 1998 IN THE COURSE OF A PROCEEDING IN THE CIRCUIT COURT OF COOK COUNTY, MUNICIPAL DEPARTMENT, FIRST DISTRICT, ENTITLED *CITY OF CHICAGO, A MUNICIPAL CORPORATION, V. JOHN SLIMAK* IDENTIFIED BY THE NUMBER 98 M1 403470 WHEREIN THERE IS SET FORTH HEREINBELOW THE LEGAL DESCRIPTION OF ALL OF THAT PROPERTY WHICH WAS IN WHOLE OR IN PART CONCERNED THEREWITH, TO WIT:

The Northeasterly 1/2 of Lot 26 in Thomas Stinson's Sub. Of Blocks 1, 2 and 10 in Canal Trustee's Subdivision of the East 1/2 of Section 31, Township 39 North, Range 14, East of the Third Principal Meridian, said Northeasterly 1/2 of said Lot 26 otherwise described as follows: Commencing at the North Corner of said Lot; thence Southwesterly on the Northwesterly Line of said Lot, 25 feet more or less to a point in said Northwesterly Line equidistant from the North and West Corner of said Lot; thence Southeasterly parallel with the Northeasterly Line of said Lot, 150 Feet more or less to the Southeasterly Line of said Lot; thence Northeasterly on the Southeasterly Line of said Lot to the East Corner of said Lot; thence Northwesterly on the Northeasterly Line of said Lot, to the Place of Beginning, in Cook County, Illinois; also Lot 25 in Stinson's Subdivision of Blocks 1, 2 and 10 in the Canal Trustee's Subdivision of the East 1/2 of Section 31, Township 39 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois.

Such legally described property consists of three (3) segments to which there has been assigned the respective property index numbers of 17-31-213-010, 17-31-213-011 and 17-31-213-012.

It is to be noted that the segments of such property have the common addresses of 3153, 3155 and 3157 So. Archer Avenue, Chicago, Illinois, irrespective of the erroneous designation thereof upon the aforesaid Release (Satisfaction) of Judgment.

It is to be further noted that the correct address of the Judgment Debtor with respect to the judgment being released, one John Slimak, is 2186 East Crown Point, Naples, Florida 34112-3676.
