WHEREAS, David J. Shestokas, hereinafter referred to as "the Petitioner", is the owner of an approximately 25 acre parcel, hereinafter referred to as "the subject property", located at 114 Illinois Street, Lemont, Plinois and legally described in Exhibit "A".

WHEREAS, the Prationer made application under the provisions of the Lemont Zoning Ordinance of 1980 (No.426), for 2 Zoning Map amendment from Village of Lemont R-4 to B-3 Arterial Commercial District; and

SECTION 1: Zoning District Change. The subject property described above is hereby rezoned from its present Village of Lemont R-4 Single-family Detached Residence District to Village of Lemont B-3 Arterial Commercial District. The zoning map of the Village of Lemont is hereby amended in accordance with the provisions of this Ordinance.
