

FIRST AMENDMENT TO CITY CENTER CLUB, 208 WEST WASHINGTON AND WASHINGTON FRANKLIN SELF PARK DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS

This Amendment is made by City Center Lofts, L.L.C., an Illinois limited liability company, Concord City Centre, LLC, an Illinois limited liability company and City Center Club Condominium Association, an Illinois not for profit corporation (the "Amending Parties") and consented to by the Secured Property Lenders who have executed consents attached hereto.

RECITALS

That certain City Center Club, 208 West Washington and Washington Franklin Self Park Declaration of Covenants, Conditions, Restrictions and Easement (the "Declaration") was recorded on June 3, 1999 as Declared No. 99530391. The Declaration was recorded against the Total Property which is legally described in Exhibit Z hereto. Under Section 27.4 of the Declaration, the Declaration may be amended by an instrument signed by the Owners and the Secured Property Lenders (as those terms are defined in the Declaration). Section 27.4 provides that so long as a portion of the Total Property is submitted to the Act, the Condominium Association which administers such portion may execute an amendment on behalf of all Unit Owners in the condominium in such portion (as those terms are defined in the Declaration). As of the date hereof, the Amending Parties own or administer 100% of the Total Property and, as such, may amend the Declaration with the consent of the Secured Property Lenders.

The Amending Parties desire to clarify the definition of the term "parking space" as that term is used in Article VII of the Declaration. Accordingly, the Amending Parties hereby amend and clarify the Declaration as follows:

- 1. As used in the Declaration the term "parking space" or "parking spaces" shall mean (i) a condominium unit which is designed and intended for the parking of a motor vehicle or vehicles ("Parking Space Unit") and which has been sold and conveyed by the declarant under the applicable Condominium Declaration to the first purchaser thereof, (ii) a limited contrion element parking space which is designed and intended for the parking of a motor vehicle or motor vehicles ("Parking Space LCE") and which has been assigned to a residential unit which has been sold and conveyed to the first purchaser thereof by the declarant under the applicable Condominium Declaration, or (iii) a Parking Space Unit or Parking Space LCE which is otherwise sold, assigned or leased to any third party or parties or is otherwise placed in service for use by the issuance of a parking access card or cards by the Owner of the Garage Property (as defined in the Declaration).
- 2. As hereby amended, the Declaration is ratified and confirmed and shall continue in full force and effect.
