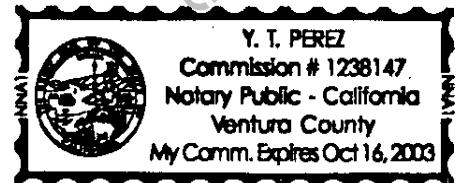

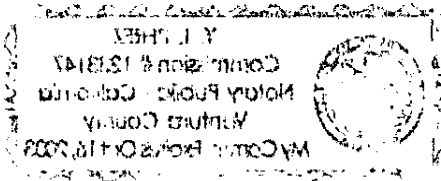


EXHIBIT A
