3. Defendant(s) shall schedule and permit interior inspections of the building to verify compliance with the terms of this order.

4. The court reserves jurisdiction of this matter for the purpose of modification, enforcement or termination of this permanent injunction, including the adjudication of contempt proceeding if the permanent injunction is violated which could result in the imposition of a fine and/or incarceration.
