WITNESSETH, that the Grantor, for and in consideration of the sum of Ten and No/00 (\$10.00) Dollars and other valuable consideration in hand paid by the Grantees, the receipt whereof is hereby acknowledged, and pursuant to authority of the Manager of said limited liability company, by these presents does CONVEY AND WARRANT unto the Grantees, Eugene Gutierrez and Kimberly Gutierrez, husband and wife, not as joint tenants or tenants in common, but as tenants by the entirety, and to their heirs and assigns, forever, all the following described real estate, situated in the County of Cook and State of Illinois known and described as follows:

This Warranty Deed is subject to all rights, easements, covenants, conditions, restrictions and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.

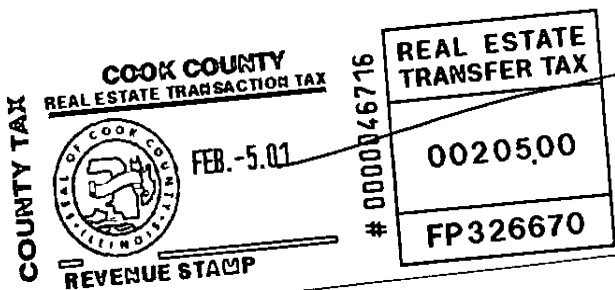
