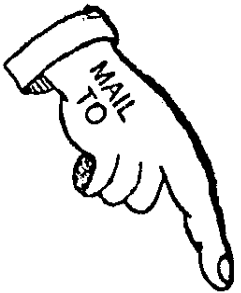

**CONSENT JUDGMENT BETWEEN CLIENT AND COUNSEL FOR

THIS CAUSE COMING ON TO BE HEARD upon the Verified petition for Entry of a Consent Judgment for attorney's Fees and Costs in the above-captioned cause pursuant to 750 ILCS 5/508(d), the Court having reviewed a copy of said Verified Petition for Entry of a Consent Judgment for Attorney's Fees and Costs, the Affidavit of FRANK T. STEPONATE, attorney for FELICIA L. FOSTER, in support of said Verified Petition as well as the Affidavit of FELICIA L. FOSTER, FELICIA L. IT IS HEREBY ORDERED: That a Judgment in favor of FRANK T. STEPONATE, Attorney at Law, 30 N. LaSalle, Suite 2140, Chicago, Illinois 60602, is entered against FELICIA L. FOSTER, in the amount of \$2,653.30 for attorney's fees and costs as a result of services rendered by FRANK T. STEPONATE to FELICIA L. FOSTER in the above captioned proceedings and that statutory interest shall accrue on the unpaid balance of said Judgment at the rate of nine (9%) percent a per annum until paid in full.
