That on or about June 7, 2000, the Claimant made a contract with one or more of the above named Owners under which Claimant agreed to act as the General Contractor for the renovation of the structure on the above described property as more fully described in the written Construction Documents between the Claimant and Maria Kurt, and other improvements at the above described Real Estate for the sum of \$216,869.99 plus extra and additional materials and labor in the amount of \$125,464.01 totaling \$342,334.00, and completed work to the value of \$330,334.00 pursuant said Construction Documents.

3. With the knowledge and consent of the Owners, the Claimant performed the contract and all extra and additional material and labor.

4. As of the date hereof, there is due, unpaid, and owing to the Claimant, after all credits, the principal sum of \$115,494.70, plus interest which bears a statutory rate of 10% per annum.
