THIS MORTGAGE ("Security Instrument") is given on December 27, 2000. The mortgagor is Terrance F. Dompke and Deborah L. Dompke, his Wife ("Borrower"). CONDOMINIUM RIDER

THIS CONDOMINIUM RIDER is made this 27th day of December, 2000, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Note to Merrill Lynch Credit Corporation (the "Lender") of the same date and covering the Property described in the Security Instrument and located at: 1096 Savoy Court Elk Grove, Illinois 60007. The Property includes a unit in, together with an undivided interest in the common elements of, a condominium project known as: The Arbor Club (the "Condominium Project"). If the owners association or other entity which acts for the Condominium Project (the "Condominium Project") holds title to property for the benefit or use of its members or shareholders, the Property also includes Borrower's interest in the Owners Association and the uses, proceeds and benefits of Borrower's interest.

Condomnation Covenants. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender number covenant and agree as follows:

- A. Condominum Obligations. Borrower shall perform all of Borrower's obligations under the Condominium Project's Constituent Documents.
