

## **CLAIM FOR LIEN**

The undersigned claimant, Emerald Sewer & Plumbing, Inc., of 2335 W. 113th Place, Chicago, IL 60643, makes the following statement and claims a mechanic's lien under the Mechanics' Lien Act of the State of Illinois, as set forth in 770 ILCS 60/1 et seq. (formerly Ill. Rev. Stat. ch 82, par. 1 et seq.), and states that:

- 1. The following described real property, 1628 W. Catalpa Ave., Chicago, IL 60640, is now owned by Darius Hurley.
- 2. On August, 2000, Darius Hurley was the owner of the property described above, on which day such owner contracted with Frank Hall, D/B/A Arco Interiors as an original contractor to build on the premises described above.
- 3. On 9/1/00, on which date Darius Hurley was still the owner of the property described above, the original contractor entered into a contract with the claimant, whereupon claimant ogreed to perform the tasks set forth in paragraphs 1 and 2 of exhibit "A" (see attached Exhibit A), for the building and improvements on the property located at 1628 W. Catalpa. Claimant agreed to perform said tasks in exchange to the contract price of \$11,200.00, plus extras, if any, contracted for afterwards, which contract price was to be paid as follows: \$5,000 as down payment, \$7,200 to be paid after completion.
- 4. On 9/17/00, the claimant completed performance of his contract in that he has completed all labor and delivered all materials required under the contract to the site of the improvements on the property.
- 5. There is now justly due claimant, after allowing to owner ail credits, deductions, and set-offs, \$7,200, which is still unpaid; a copy of the account is attached to this claim as Exhibit "A", in addition to a bounced check from Frank Hall, D/B/A Arco Interiors, which is attached as Exhibit "B".

6. The claimant now claims a lien on the premises and all improvements on it, against all persons interested, and also claims a lien on any amounts due from the owner to the original contractor, for \$7,200.00, with interest, according to the statute.


