That said contractor is entitled to credits on account thereof in the amount of 0 Dollars, leaving due, unpaid and owing to claimant the sum of \$12,045.39 for which, with interest, the claimant claims a lien on said land and improvements and on the money or other consideration due, or to become due, from the owner under said contract against said contractor and owner.

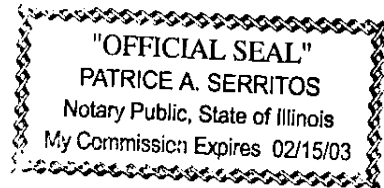
