

AMENDMENT TO DECLARATION OF EASEMENTS, RESTRICTIONS AND COVENANTS FOR INSIGNIA COURT SOUTH COMMUNITY ASSOCIATION

This Amendment to the Declaration of Easements, Restrictions and Covenants for Insignia Court South Community Association, made and entered into this <u>loth</u> day of January, 2001, by INSIGNIA COURT SOUTH, L.L.C., an Illinois limited liability company (hereinafter referred to as "Declarant").

WITNESSETH

WHEREAS, Declarant did heretofore execute and record a certain Declaration of Easements, Restrictions and Covenants for Insignia Court South Community Association, dated April 1, 1999 and recorded with the Recorder of Deeds of Cook County, Illinois on May 19, 1999 as Documents No. 99-483708 (the "Declaration"): and

WHEREAS, pursuant to Paragraph 8.02 thereof the Declaration may be amended by Declarant, prior to the conveyance of any Dwelling Unit to any other Owner, and

WHEREAS, Declarant has not as of this date conveyed any 5 welling Unit to any other Owners; and

WHEREAS, Declarant does hereby intend to amend the Declaration as nereinafter provided:

NOW THEREFORE, Declarant hereby declares that the Declaration is amended to provide as follows:

1. Section 4.02 of the Declaration is hereby amended to provide that the assessments shall be further used for the purpose of maintenance, repair and replacement of the exterior, structure, roof, and landscaping of all Dwelling Units, including, but not limited to the costs of all fire and casualty insurance premiums with respect thereto.

- 2. Section 4.02 of the Declaration is further amended to provide for all other improvements on the Community Area, and added planting, replanting, care, and maintenance of trees, shrubs, flowers, grass, and all other landscaping of the Community Area and the maintenance of all landscaping in the right-of-way.
- 3. Except as specifically herein provided, the Declaration shall remain unmodified and in full force and effect.
