



### THIRD ADD ON AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR SOUTHGATE ON THE GLEN CONDOMINIUM

This instrument, is made on the date set forth below by GLENBASE VENTURE, a Joint Venture of ODESIGN, INC., an Illinois corporation, and GLENBASE PARTNERS, LLC, an Illinois limited liability company, hereinafter referred to as "Developer" or "Declarant":

WHEREAS, the Declarant has heretofore caused to be recorded with the Recorder of Deeds of Cook County, Illinois on September 14, 2000, as Document No. 00-717613, a Declaration of Condominium Ownership for SOUTHGATE ON THE GLEN CONDOMINIUM, ("Declaration") pursuant to the Condominium Property Act ("Act") of the State of Illinois, submitting the real property ("Property") described in Exhibit A thereto, to the provisions of the Act; and

WHEREAS, additional real property was added to the Property pursuant to First Add-On Amendment recorded as Document No. 00-907913 on November 17, 2000, and the Second Add-On Amendment recorded as Document No. 00-972964 on December 21, 2000; and

WHEREAS, the Declaration reserves to the Declarant, the right to add to the Property (as defined in the Declaration, and thereby add to the Condominium created by the Declaration all or any portion of the Additional Land described in Exhibit E of the Declaration; and

WHEREAS, the Declarant now desires to add to said Property, and submit to the provisions of the Act and the Declaration, the Additional Land described as Lots 204 and 406 in Amended Exhibit A attached hereto.

NOW, THEREFORE, the Declarant does hereby amend the Declaration as follows:

- 1. The Additional Land and improvements, consisting of two (2) multi-family buildings, namely Buildings 204, (a three (3) story building) and 406, (a two (2) story building), as depicted on Exhibit B hereto (Third Add-On Amendment Plat to Declaration), containing six (6) Units in Building 204 and six (6) Units in Building 406 are hereby added to Exhibit B of the Declaration pursuant to paragraph 3 below; are hereby submitted to the provisions of the Act as a part of the Condominium in accordance with, and shall be decred to be governed in all respects by, the terms and provisions of the Declaration; and are included in the legal description set forth in Amended Exhibit A.
- 2. Exhibit A of the Declaration as amended is hereby amended by substituting, therefore, Amended Fxhibit A which is attached hereto.
- 3. Exhibit B of the Declaration as amanded is hereby amended by the addition of Exhibit B attached hereto.
- 4. Exhibit C of the Declaration as amended is hereby amended by substituting therefore, Amended Exhibit C which is attached hereto and which shows the percentage of ownership in the Common Elements appurtenant to each Unit shifted to the new percentages set forth in said Amended Exhibit C.
- 5. The existing Units shall be entitled to their respective percentages of ownership, as amended and adjusted in any added Common Elements as well as the existing Common Elements.

- 6. The added Units shall be entitled to their respective percentage of ownership, in any added Common Elements as well as the existing Common Elements.
- 7. Any added Common Elements contained in the added property are hereby granted and conveyed to the Owners subject to the provisions of the Act and the Declaration as amended.
- 8. Exhibit E of the Declaration as amended is hereby amended by substituting, therefore, Amended Exhibit E which is attached hereto.
- 9. Except an expressly set forth herein, the Declaration shall remain unchanged and in full force and effect in accordance with its terms.
