THIS AMENDED MEMORANDUM OF LEASE, dated this 23rd day of October, 2000, is between *LASALLP NATIONAL BANK, AS SUCCESSOR TRUSTEE TO THE EXCHANGE-NATIONAL BANK OF CHICAGO, AS TRUSTEE UNDER TRUST AGREEMENT DATED LEBRUARY 21, 1950 AND KNOWN AS TRUST NUMBER 1464, and ELLEN SIGAL ("Land o'd"), whose address is Chicago, Illinois, and McDONALD'S CORPORATION, a Delaware corporation ("Tenant"), whose principal place of business is located at One McDonald's Plaza, Oak Brook, Illinois 60523.

- 1. TERM: TO HAVE AND TO HOLD for a term ending on September 30, 2022.
- 2. OPTION TO PURCHASE: Landlord grants Tenant an option to purchase the Premises.
- 3. FIRST REFUSAL: Landlord grants Tenant the right of first refusal to lease and purchase the Premises.
- 4. COVENANT NOT TO COMPETE: If Landlord shall be the owner of any land adjacent to the Premises, Landlord will not use, nor permit others to use, said land for a restaurant of any type.
- 5. MEMORANDUM: The rentals to be paid by Tenant and all of the obligations and rights of Landlord and Tenant are set forth in the Ground Lease dated November 24, 1970, as amended by agreement(s) dated July 6, 1972, June 19, 1992 and July 17, 2000 (the "Lease") executed by the parties. This instrument is merely an Amended Memorandum of Lease and is subject to all the terms, conditions and provisions of the Lease. In the event of any inconsistency between the terms of the Lease and this instrument, the terms of the Lease shall prevail as between the parties. This Amended
