PROMISSORY NOTE AGREEMENT

This agreement entered into this 30th day of Statember 2000

Rosie L. Davenport and Dana Edward Langham hereinafter referred to as party of the first part and Roshelle Davenport, herein referred to as party of the second part.

Debtor agrees that she will pay this entire loan back to secured party within the next eighteen (18) months (March 2002). Twelve percent (12%) is the interest rate of this loan.

The interest and principal are amortized over fifteen (15) years. There is no prepaying penalty if Debtor wishes to pay down the principal.
