Johnson & Son**, contractor, stating as follows:

1. At all times relevant hereto and continuing to the present, **Owner** owned the following described land in the County of Cook, State of Illinois, to wit:

which property is commonly known as the Lock Up Kinzie, 350 W. Kinzie, Chicago, Illinois.


2. On information and belief, said Owner contracted with **G.A. Johnson & Son** for certain improvements to said premises.

3. Subsequent thereto, **G.A. Johnson & Son** entered into a subcontract with the Claimant to furnish and install roll up doors and components.

4. The Claimant completed its work under its subcontract on November 30, 2000, which entailed the delivery of said materials and labor, for which the amount of **Eighty-eight Thousand Six Hundred Sixty-seven and 00/100 Dollars (\$88,667.00)** remains unpaid.

5. There is due, unpaid and owing to the Claimant, after allowing all credits, the sum of **Eighty-eight Thousand Six Hundred Sixty-seven and 00/100 Dollars (\$88,667.00)** for which, with interest, the Claimant claims a mechanic's lien and hereby notifies the Owner and other parties named above of its claim for a lien on said land and improvements and on the monies or other consideration due or to become due from the Owner under said contract against said contractor, Owner and others claiming an interest in said property.

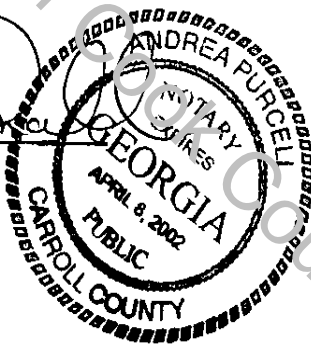
