GPAGINAL CONTRACTOR'S CLAIM FOR LIEN

That at the special instance and request of the Owner, Corrigan furnished extra and additional materials and labor to the amount of Seventeen Million Four Hundred Seventy-Two Thousand Six Hundred Eighty-Seven and 49/100 Dollars (\$17,472,687.49) and completed work to that amount on February 28, 2001.

That after allowing the Owner all credits, there remains due to Corrigan a balance of One Million Nine Hundred Sixty-Seven Thousand Elever and 65/100 Dollars (\$1,967,011.65), for which, with interest, Corrigan claims a lien on the Property and the improvements thereon.
