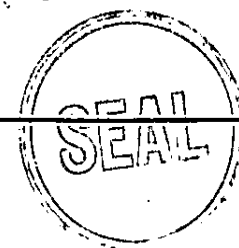

Comes now the Plaintiff, in person and by counsel, and the Defendant having appeared in person and counsel, and this cause being set for trial this date and hour is now submitted.

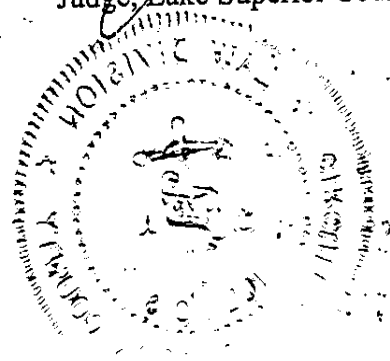

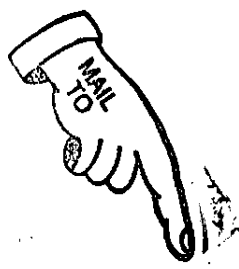
