15. Governing Law; Severability. This Security Instrument shall be governed by federal law and the law of the jurisdiction in which the Property is located. In the event that any provision or clause of this Security Instrument or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Security Instrument or the Note which can be given effect without the conflicting provision. 17. Transfer of the Property or a Beneficial Interest in Borrower. The preceding two sentences shall not apply to anything affecting the presence, use, or storage on the Property of small quantities of Hazardous Substances that are generally affected by the Property that is in violation of any Environmental Law. The notice will state the name and address of the new Loan Servicer and address to which payments should be made. The notice will also contain any other information required by applicable law.

20. Hazardous Substances. Borrower shall not cause to permit the presence, use, disposal, storage, or release of any Hazardous Substances that will not cause to permit the presence, use, disposal, storage, or release of any Hazardous Substances on or in the Property that is in violation of any Environmental Law.

19. Sale of Note; Change of Loan Servicer. The Note or partial interest in the Note (together with this Security instrument) may be sold one or more times without prior notice to Borrower. A sale may result in a change in the entity (known as the "Loan Servicer") that collects monthly payments due under the Note and this Security instrument. There also may be one or more changes of the Loan Servicer unrelated to a sale of the Note. If there is a change of the Loan Servicer, Borrower will be given written notice of the change in accordance with paragraph 14 above and the new Loan Servicer will be given written notice of the change in accordance with paragraph 14 above and applicable law.

20. Partial Acceleration. This instrument had occurred. However, this right to reinstate shall not apply in the case of acceleration as it no acceleration by Borrower, this Security instrument and the obligations secured hereby shall remain fully effective as reinstatement by Borrower, this Security instrument shall continue unchanged. 


