**DISCLAIMER OF INTEREST AND
CORRECTIVE ASSIGNMENT OF MORTGAGE**

Pursuant to a certain Mortgage Loan Purchase Agreement (JHREF Loans), dated as of March 22, 2000, between John Hancock Real Estate Finance, Inc., a Delaware corporation ("**Assignor**"), having a mailing address of 200 Clarendon Street, Boston, Massachusetts 02117, and Morgan Stanley Dean Witter Capital I Inc., a Delaware corporation ("**Depositor**"), and a certain Pooling and Servicing Agreement, dated as of March 1, 2000, among Depositor and LaSalle Bank National Association, a national banking association, as Trustee for Morgan Stanley Dean Witter Capital I Inc., Commercial Mortgage Pass-Through Certificates, Series 2000-LIFE1 ("**Assignee**"), having a mailing address of 135 South LaSalle Street, Chicago, Illinois 60603, Attn: Asset-Backed Securities Trust Services Group - Morgan Stanley Series 2000-LIFE1, among others, Assignor agreed to transfer to Assignee, and Assignee agreed to serve as trustee for a Trust established for the Holders of Depositor's Commercial Mortgage Pass-Through Certificates, Series 2000-LIFE1, certain mortgage loans, including the mortgage deed(s) or deed(s) of trust (the "**Mortgage**") and assignment(s) of leases and rents (the "**Assignment of Leases**") described on Exhibit "A" annexed hereto and made a part hereof, and the indebtedness secured thereby (the "**Loan**").

Subsequent to the transfer of the Loan by Assignor to Assignee, due to a scrivener's error, the Mortgage and the Assignment of Leases were erroneously assigned of record by John Hancock Life Insurance Company ("JHLICO") to LaSalle Bank National Association, as Trustee for Depositor ("**LaSalle**"), said Assignments of Mortgage and Assignment of Leases described on Exhibit "B" annexed hereto and made a part hereof.

Assignor, JHLICO, LaSalle and Depositor each hereby acknowledge, confirm and agree that (i) the Mortgage and the Assignment of Leases were assigned of record by JHLICO to LaSalle in error, JHLICO had no interest in the Loan when it assigned it to LaSalle and Assignor had previously sold, granted, assigned, transferred and conveyed all its right, title and interest in and to the Loan to Assignee, and (ii) terminate in all respects any effect of the Assignment of Mortgage. LaSalle and Depositor further hereby disclaim any interest as the holder of record of the Mortgage and the Assignment of Leases, and hereby grant, assign, transfer, convey and quit-claim any right, title and interest that they may have acquired, or may have been purported to have been acquired, as the holder of record in and to the Mortgage, the Assignment of Leases and the Loan to Assignee.
