That at the special instance and request of the Owner, the Claimant furnished extra and additional materials at and extra and additional labor on said premises of the value of \$280.00, and completed same on October 18, 2000;

That the Owner is entitled to credits on account thereof as follows, to-wit: \$0, leaving due, unpaid and owing to the Claimant, after allowing all credits, the balance of Nine Thousand Five Hundred Eighty Dollars (\$9,580.00) for which, with interest, the Claimant claims a lien on said land and improvements.

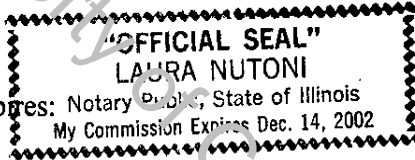
