- A. - C. Assignee is desirous of acquiring from Assignor Parking Space No. 70 as a Limited Common Element serving exclusively Unit 2000 owned by Assignee and Assignor is willing to transfer the same to Assignee, all in accordance with and subject to the terms, provisions and conditions of Paragraph D of Article VI of the Declaration of Con.

TERMS AND CONDITIONS

NOW, THEREFORE, in consideration of the foregoing Recitals, each of which is made a contractual part hereof, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

- 1. The capitalized terms contained in this Assignment shall have the same meanings as in the Declaration of Con unless defined herein or the context requires or suggests therwise. 70
- 2. Assignor hereby assigns and transfers to Assignee all of Assignor's right, title and interest in and to Parking Space No. 10, which was Limited Common Element exclusively serving Unit , with the result that such Parking Space No. 185 shall be and become a Limited Common Element serving exclusively Unit owned by Assignee.
- 3. Assignee accepts the assignment and transfer by Assignor of Parking Space No. 70 and agrees that it is a Limited Common Element serving exclusively Unit 1905 owned by Assignee and that such assignment and transfer of Parking Space No. 70 is made in compliance with, and subject to all the applicable terms, provisions and conditions of the Declaration of Condominium including
