THIS CAUSE COMING TO BE HEARD ON PLAINTIFF'S MOTION FOR SUMMARY JUDGMENT ON COUNT IV OF PLAINTIFF'S FIRST AMENDED COMPLAINT, NOTICE HAVING BEEN GIVEN AND THE COURT BEING FULLY ADVISED IN THE PREMISES, IT IS HEREBY ORDERED THAT:

PLAINTIFF'S MOTION FOR SUMMARY JUDGMENT ON COUNT IV IS GRANTED, THE COURT FINDING THAT THERE IS NO GENUINE ISSUE OF MATERIAL FACT. 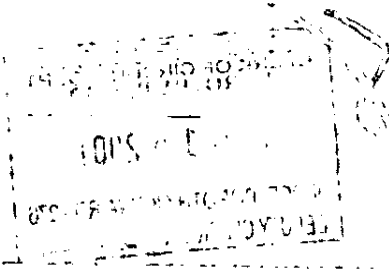
