

Note 1: All fees in connection with the reinstatement must be in the form of a certified check, cashier's check, Illinois attorney or CPA's check or money order made payable to the "Secretary of State".

This method of payment includes all filing fees and penalties.

Note 2: If the corporate name which the corporation had at the time of dissolution or revocation is not available for use at the time of reinstatement, the corporation shall set forth the new name by which it will hereafter be known. A change of corporate name must also be properly effected in accordance with the provisions of the General Not For Profit Corporation Act of 1986. For domestic corporations, articles of amendment must be filed, pursuant to Section 110.30. For foreign corporations, if the name has been changed, an application for amended certificate of authority, (form NFP113.40), together with a certified copy of the amendment, must be filed pursuant to Section 113.40.

Note 3: If a foreign corporation's true name was not available for use when the original certificate of authority was issued, the corporation had to adopt an assumed corporate name for use in Illinois. When reinstating, or application for an assumed corporate name, pursuant to Section 104.15, must accompany the reinstatement application.

If either or both the registered agent or the registered office of the corporation has changed since the time of dissolution or revocation, the corporation shall properly report such a change on form NP-105.10.
